

**Ehr Attestation Guide**

Beginning in 2019, all eligible professionals (EPs), eligible hospitals, dual-eligible hospitals, and critical access hospitals (CAHs) are required to use 2015 edition certified electronic health record technology (CEHRT) to meet the requirements of the Promoting Interoperability Program.

The 2018 attestation deadline has been extended to April 5, 2019 to compensate for periods of SLR downtime in recent weeks. The deadline will be 9PM on April 5, 2019 but users should be aware that the SLR Helpdesk will not be available after 5PM.
